**HMO's:** There's no update at present.

**Penkhull Farm:** John as spoken to the architect regarding putting the application In again as it had not gone in & the clients want to go ahead. Sarah said that There is a hold up in the planning department at the moment due to new systems in place.

**Dove Cottage:** there has been a meeting with the Planning officer & the owners & the pre plan advise was ignored windows, style etc. there has been a heavy costing already which has caused a lot of stress. Eg; parking & visitors on site which was not done by the architect Wall & hedge will be going back up.

**PENKHULL EDUCATION CENTRE**; The Owen Project are interested in buying this. Sarah felt that this was not a good idea. Bruce says that they are not a charity & was not impressed. Sarah wrote to Luke regarding Penkhull Education Centre.

Karen said about the Mystery players and The Owen Project were involved, but Karen is the organiser, it's a 2 day event. Lesley & Steve (Chair of The Mystery Plays) have spoken to the Owen project.

Bruce commented that all that goes on in the village, they want to be involved with food banks, after school clubs etc. Bruce was removed from a group chat with the residents who are wanting to purchase the education centre. BJ as great doubts about the RA having any dealings with the Owen Project in the future. It was proposed to the committee that currently, The PRA have no connection in the future with The Owen Project.

MO agreed with BJ's stated objectives above, and Bruce's strong views against The Owen Project.
